NOTICE OF INITIATING RULE MAKING AND RULE MAKING SESSION

The Public Service Commission ("Commission") hereby initiates an Administrative Docket, RM 54, to consider revisions to the Code of Maryland Regulations ("COMAR") 20.32, 20.51, 20.53 and 20.59 regarding Competitive Electricity and Gas Supply. On November 13, 2014, the PSC Leader in Maryland Public Service Commission Public Conference 35 filed the Final Report, Draft Regulations and Recommendation for Rulemaking ("Final Report") that contained proposed revisions to COMAR 20.32, 20.51, 20.53 and 20.59 that would update and further adopt consumer protection regulations for the Maryland electric and gas competitive supplier market. On December 4, 2014, the PSC Leader filed revised proposed revisions to those same regulations that further conform to COMAR drafting requirements. ²
