All reports must be submitted on the Commission's form for the report year. You must use the appropriate form to submit your report. If you need more space than is provided on the form or if you are attaching exhibits, all attachments must be labeled or tabbed to identify the report item to which they correspond. You are also required to file an electronic version of the document using any version of Microsoft Word or Adobe PDF software. A compact disc must accompany the paper copy to be filed with the Maryland Public Service Commission.

COMAR 20.61.04.01 Consumer Protection

- A. A supplier shall retire one renewable energy credit for each megawatt-hour (MWh) of retail sales of electricity marketed as having characteristics of a Tier 1 renewable source or a Tier 2 renewable source.
- B. A supplier contract for the sale of electricity that is marketed as renewable or having the characteristics of
- Tier 1 renewable source or Tier 2 renewable source shall include:
 - (1) The RPS for each year covered by the contract of sale; and
 - (2) A statement that Tier 1 renewable source or Tier 2 renewable source RECs retired may be used to meet the supplier's RPS obligation for that particular sale; and
 - (3) A statement that a supplier may meet its RPS obligation by paying a compliance fee to the Maryland Renewable Energy Fund under Public Utility Companies Article, §7-705(b), Annotated Code of Maryland.
- C. The statement required by §B(3) of this regulation shall include, if appropriate, the dollar amount of the Tier 1 and Tier 2 compliance fee.
- D. Report Required.
 - (1) On or before April 1 of each year, a supplier shall file with the Commission a report of any activity under §A of this regulation on a form provided by the Commission.
 - (2) The supplier report required under C(1) of this regulation shall include:
 - (a) Total retail sales of electricity marketed as renewable energy in Maryland by the supplier for the preceding calendar year; and
 - (b) Total RECs associated with sales of renewable energy in Maryland retired by the supplier during the preceding calendar year.
