## BALTIMORE CITY TAXICAB RATES

Approved by the Maryland Public Service Commission - Effective September 1, 2008

## METERED RATES

Except for the flat rates listed and certain non-metered rates listed below, charges for transportation must be computed by taximeter at the following rates:
\$1.80 First $\mathbf{1 / 1 1}$ mile or fraction thereof.
\$0.20 Each additional $\mathbf{1} 11$ mile or fraction thereof.
\$ 0.20 Each 30 seconds of waiting time.

## NON-METERED RATES

The following additional rates may be charged, even though they cannot be computed by taximeter:
$\$ 0.30$ Per each mile traveled outside the City of Baltimore or fraction thereof.
\$1.00 Surcharge when taxicab arrives within 30 minutes of call for service.
\$1.00 Call service furnished and not used.
\$0.50 Night surcharge per trip (between 9:00PM and 5:00AM).

## SMOKING IS NOT PERMITTED IN THE TAXICAB

Drivers must accept, and transport where directed, any orderly person/party unless previously engaged. A taxicab may not carry more passengers than the vehicle is designed to seat. Drivers may refuse to transport freight or animals, except service animals (any guide dog, signal dog or other animal trained to work or perform tasks for a person with a disability).

## Baltimore City Passenger-For-Hire Services Tax

Effective October 1, 2013, Baltimore City Code, Art. 28, Sub. 24, requires that a tax be collected for taxicab trips between points within Baltimore City, from a point within Baltimore City to a point outside Baltimore City or from a point outside of Baltimore City to a point within Baltimore City $25 \$$ for each passenger. The tax will be added to the fare at the end of your trip.

## FLAT RATE TRIPS

No other stops may be made along the way. The flat rate applies regardless of the number of passengers/parties that share a ride. No other charges may be added to these flat rates.

## \$30 FLAT RATE PER TAXICAB FROM DOWNTOWN BALTIMORE TO BWI MARSHALL AIRPORT

For service from this shaded zone to BWI Airport, the driver must charge a flat rate of \$30 PER TAXICAB. No additional charges may be added if passengers/parties exit the taxicab at different airline terminals within BWI.


## \$30 FLAT RATE PER TAXICAB FROM CRUISE SHIP TERMINAL TO BWI MARSHALL AIRPORT

For service from the South Locust Point Cruise Ship Terminal at 2001 E. McComas Street in Baltimore City to BWI Airport, the driver must charge a flat rate of \$30 PER TAXICAB. No additional charges may be added if passengers / parties exit the taxicab at different airline terminals within BWI.

## CRUISE SHIP TERMINAL FLAT RATE FARES TO POINTS WITHIN CITY OF BALTIMORE Approved by the MD PSC - Effective July 18, 2014

\$12.50 - Cruise Ship Terminal to Penn Station (train) OR Penn Station to Cruise Ship Terminal
\$9.50 -Cruise Ship Terminal to World Trade Center OR World Trade Center to Cruise Ship Terminal
\$5.50 - Cruise Ship Terminal to Ft. McHenry OR Ft. McHenry to Cruise Ship Terminal
