Due to the recent inclement weather, the January 25, 2016 bids for contracts for a portion of the residential and Type I customer loads by the Potomac Edison Company ("PE") and the Type II customer loads for PE, Baltimore Gas and Electric Company ("BGE"), Delmarva Power and Light Company ("DPL") and Potomac Electric Power Company ("Pepco") have been postponed until February 1, 2016. Therefore, the Public Service Commission ("Commission") hereby gives notice of a reschedule of the January 28, 2016 hearing to Thursday, February 4, 2016, at 4:00 p.m., for the Standard Offer Service ("SOS") Bid Monitor consultant and the Commission's Technical Staff to brief the Commission on the conduct of the February 1, 2016 solicitations for offers for contracts for a portion of the residential and Type I customer loads by PE and the results, in conjunction with the hearing for review of the PE's, BGE's, DPL's and Pepco's Type II SOS procurement results. PE is hereby directed to provide Commission Staff no later than 9 a.m., Wednesday, February 3, 2016, with individual class retail bill impact data consistent with the results of the February 1, 2016 bids to ensure that Staff is able to file its written testimony in the matter prior to the hearing commencement time.

Provisions of the 2016 Request for Proposals for Full Requirements Wholesale Electric Power Supply issued for the Type II SOS bidding to be conducted in 2015 and 2016, established bid week schedules similar to those established in Order No. 81102, included holding hearings to review the results of the Type II SOS bidding.
