AMENDED NOTICE OF REQUIRED ACCESS TARIFF FILINGS

To: All Maryland Regulated Facilities-Based Local Exchange Carriers with Approved Maryland Intrastate Access Tariffs

On May 5, 2015, the Commission issued a Notice of Required Access Tariff Filings instructing all Maryland regulated facilities-based local exchange carriers with approved Maryland Intrastate Access Tariffs to file appropriate tariff revisions no later than June 1, 2015 to ensure compliance with Federal Communications Commission ("FCC") Order # FCC 11-161, dated December 29, 2011.

The Commission revises its May 5, 2015 Notice to account for the FCC benchmark rule¹ provision which allows competitive local exchange carriers ("CLECs") that benchmark their rates to underlying local exchange carriers ("LECs") rates, additional time to file proposed tariff revisions. All other aspects of the Commission's May 5th Notice remain in effect.

Pursuant to this amended Notice, the Commission will allow those Maryland CLECs that benchmark their rates to the rates of underlying Maryland LECs, additional time to file their intrastate access tariff revisions to make its rates effective coincident with its interstate access tariff filing, but not later than July 31, 2015.

By this modification, any CLEC benchmarking against Verizon must file its revised intrastate access tariff with the Commission by June 29, 2015 and may elect to make its tariff effective coincident with its interstate access filing with the FCC but not later than July 31, 2015.
