Public Hearing Scheduled for Baker Point Solar Project

(BALTIMORE, MD-February 24, 2016) – A public hearing for comment will be held on **Thursday, March 10, 2016 at 7pm** in the matter of the application of OneEnergy Baker Point Solar, LLC to construct a 9 MW solar photovoltaic generating facility on property located at the intersection of Creagerstown Road (MD 550) and Old Frederick Road south of Creagerstown in Frederick County. The application has been docketed by the Maryland Public Service Commission as Case No. [9399](#).
