The Public Service Commission ("Commission") hereby gives notice of a hearing on Thursday, October 20, 2016, at 3:00 p.m., for the Standard Offer Service ("SOS") Bid Monitor consultant and the Commission's Technical Staff to brief the Commission on the conduct of the October 17, 2016 solicitations for offers for quarterly contracts for the Type II SOS loads by each of The Potomac Edison Company, Baltimore Gas and Electric Company, Delmarva Power & Light Company and Potomac Electric Power Company (collectively, the "IOUs") and the results, in conjunction with the hearing for review of the IOUs' residential and/or Type I SOS procurement results.
