As discussed in Order No. 81102 in Case No. 9064,² the Commission will conduct a review of confidential and highly commercially sensitive bidder specific data during the process and at the hearings. The public briefing, therefore, will include only the information that can be made public under the provisions of the request for proposals and the full requirements service agreement.
