

## **NOTICE OF HEARING**

To: All Parties of Record and Interested Persons

The Public Service Commission ("Commission") hereby gives notice of a hearing on Thursday, June 14, 2018, at 3:00 p.m., for the Standard Offer Service ("SOS") Bid Monitor consultant and the Commission's Technical Staff to brief the Commission on the conduct of the June 11, 2018 solicitations for offers for contracts for a portion of the residential loads by The Potomac Edison Company ("PE") and the results, in conjunction with the hearing for review of the PE's, Baltimore Gas and Electric Company's, Delmarva Power & Light Company's and Potomac Electric Power Company's Type II SOS procurement results.<sup>1</sup> PE is hereby directed to provide Commission Staff no later than 9 a.m., Wednesday, June 13, 2018, with individual class retail bill impact data consistent with the results of the June 11, 2018 bids to ensure that Staff is able to file its written testimony in the matter prior to the hearing commencement time.

The hearing will be held in the Commission's 16<sup>th</sup> Floor Hearing Room, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202. As discussed in Order No. 81102 in Case No. 9064,<sup>2</sup> the Commission will conduct a review of confidential and highly
