The hearing will be held in the Commission's Frank O. Heintz Hearing Room, 16<sup>th</sup> Floor, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202. As discussed in Order No. 81102 in Case No. 9064, the Commission will conduct a review of confidential and highly commercially sensitive bidder specific data during the process and at the hearings. The public briefing, therefore, will include only the information that can be made public under the provisions of the request for proposals and the full requirements service agreement. Additionally, the Commission will solicit remarks from any of the parties and members of the public following the briefing. To the extent necessitated by confidentiality considerations, the Commission will employ *in camera* procedures.
