NOTICE OF HEARING

To: All Parties of Record and Interested Persons

The Public Service Commission ("Commission") hereby gives notice of a hearing on Thursday, April 15, 2021, at 2:00 p.m., for the Standard Offer Service ("SOS") Bid Monitor consultant and the Commission's Technical Staff to brief the Commission on the conduct of the April 12, 2021 solicitations for offers for contracts for a portion of the residential customer loads by The Potomac Edison Company ("PE") and the results, in conjunction with the hearing for review of PE's, Baltimore Gas and Electric Company's, Delmarva Power & Light Company's and Potomac Electric Power Company's Type II SOS procurement results.¹ PE is hereby directed to provide Commission Staff no later than 9:00 a.m., on Wednesday, April 14, 2021, with individual class retail bill impact data consistent with the results of the April 12, 2021 bids to ensure that Staff is able to file its written testimony in the matter prior to the hearing commencement time.

Provisions of the 2021 Request for Proposals for Full Requirements Wholesale Electric Power Supply issued for the Type II SOS bidding to be conducted in 2020 and 2021, established bid week schedules similar to those established in Order No. 81102, included holding hearings to review the results of the Type II SOS bidding.

The Commission will conduct the hearing virtually. If you would like to actively participate in the hearing, you must contact Susan Howard at susan.howard@maryland.gov by 12:00 noon on Wednesday, April 14, 2021.² Otherwise, you may watch the video of the hearing on the Commission's YouTube channel.³

As discussed in Order No. 81102 in Case No. 9064, the Commission will conduct a review of confidential and highly commercially sensitive bidder specific data during the process and at the hearings. The public briefing, therefore, will include only the information that can be made public under the provisions of the request for proposals and the full requirements service agreement. Additionally, the Commission will solicit remarks from any of the parties and members of the public following the briefing. To the extent necessitated by confidentiality considerations, the Commission will employ *in camera* procedures.
