In addition to the annual reports, at the program conclusion, the CIF recipients were also directed to provide a final report to the Commission regarding the overall performance of the approved program.

Through this Notice, the Commission hereby directs CIF recipients to file its respective fiscal year 2017 annual report no later than September 29, 2017. In addition, for those CIF recipients that have expended their total CIF award through FY 2017, the Commission directs such CIF recipients to file their respective final report to the Commission on the overall performance of the approved program no later than October 31, 2017. The final report should mimic the reporting templates used in their annual report, but summarize the entire project's performance. Furthermore, the final report should draw conclusions on the efforts made during the time it was implemented and whether it will continue via another funding source.
