NOTICE OF MODIFICATION OF HEARING SCHEDULE

On May 23, 2018, the Maryland Public Service Commission ("Commission") issued a Notice of Hearing and Opportunity to Comment in this matter. The Commission advised that it would conduct a hearing on July 26 and 27, 2018, to review the 2017 Annual Performance Reports of Baltimore Gas and Electric Company ("BGE"), Choptank Electric Cooperative, Inc. ("Choptank"), Delmarva Power & Light Company ("Delmarva"), the Potomac Edison Company ("PE"), Potomac Electric Power Company ("Pepco"), and Southern Maryland Electric Cooperative, Inc. ("SMECO") (collectively, "Electric Companies") as well as the Electric Companies' recommended reliability standards covering the years 2020 through 2023.

On July 23, 2018, BGE, Delmarva, and Pepco (collectively, "Companies") jointly filed a request asking the Commission to delay its review of the Electric Companies' recommended reliability standards covering the years 2020-2023 because the Companies needed additional time to understand and respond to the Commission's Technical Staff ("Staff") comments filed on July 19, 2018. The Companies stressed that the Staff's comments "significantly altered the target SAIDI and SAIFI levels proposed by the utilities" along with the imposition of spending levels proposed by Staff. On July 24, 2018, PE, SMECO, and Choptank filed a similar request to delay the review by the Commission of the Electric Companies' recommended reliability standards covering the years 2020-2023.

The Commission grants the requests and reschedules the review of the Electric Companies' recommended reliability standards covering the years 2020 through 2023 to August 28, 2018, beginning at 10:00 a.m. in the Frank O. Heintz Hearing Room, 16th Floor, 6 St. Paul Street, Maryland 21202, with further comments on the recommended reliability standards covering the years 2020 through 2023 due by August 22, 2018. An original and 17 paper copies, and an electronic copy, of any further comments shall be filed with Terry J. Romine, Executive
