**SUPPLEMENTAL NOTICE OF HEARING AND OPPORTUNITY TO COMMENT**

Pursuant to COMAR 20.50.12.11, Baltimore Gas and Electric Company, Potomac Electric Power Company, Delmarva Power & Light Company, Potomac Edison Company, Southern Maryland Electric Cooperative, Inc., and Choptank Electric Cooperative, Inc., (collectively, the “Electric Companies”), filed with the Public Service Commission (“Commission”) their respective 2016 Annual Performance Reports (“Reports”) on electric service reliability.<sup>1</sup> Furthermore, §7-213(f)(1), of the Public Utility Article, *Annotated Code of Maryland*, requires the Maryland Public Service Commission (“Commission”), on or before September 1 of each year, to review and determine whether each electric company has met the service quality and reliability standards adopted by the Commission.

The Commission hereby gives notice that it will conduct a legislative-style hearing on Tuesday, July 25, 2017 for the purpose of reviewing the Reports and to determine whether the Electric Companies have met the service quality and reliability standards adopted by the Commission. **In addition, the Electric Companies and the Commission’s Technical Staff (“Staff”) should be prepared to respond to Commission questions regarding the “RM 43 Work Group Report – Vegetation Management” filed by Staff on January 23, 2017 on behalf of the Work Group.**<sup>2</sup> The hearing will be held in the Commission’s 16<sup>th</sup> Floor Hearing Room, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202, beginning at 10:00 a.m. Written comments on the Reports shall be filed by Friday, July 14, 2017. An original and seventeen copies of the comments, together with an electronic copy, shall
