## NOTICE OF HEARING AND REQUEST FOR COMMENTS

#### To: Service List for Case No. 9361 and Interested Persons

On November 3, 2016, Exelon Corporation ("Exelon"), along with Montgomery County, Maryland, Prince George's County, Maryland (collectively, "the Counties"), and the National Consumer Law Center, National Housing Trust, Maryland Affordable Housing Coalition, and the Housing Association of Nonprofit Developers (collectively, "NCLC") (Exelon, the Counties and NCLC are collectively, the "Requesting Parties) jointly filed a compliance filing to implement Condition 46 (the Most Favored Nation ("MFN") provision) of Commission Order No. 86990 ("Merger Order"). According to the filing, the implementation of the MFN provision will result in Maryland's Potomac Electric Power Company and Delmarva Power & Light Company customers receiving an additional \$48,031,836 in benefits on a net present value basis (or \$60.20 per customer). The Requesting Parties have come to agreement on both the amount of additional benefits and the allocation of nearly all of the benefits and have submitted a Joint Recommendation requesting that the Commission approve the stipulation and conditions in Exhibit 1 of the compliance filing in order to implement Condition 46 of the Merger Order.

After reviewing the Requesting Parties compliance filing, the Commission has determined that a legislative-style hearing and comments from other parties in the proceeding are necessary to fully evaluate compliance with Condition 46 of the Merger Order. Accordingly, the Commission hereby provides notice of a hearing and comment period as follows:
