NOTICE OF EVENING HEARINGS FOR PUBLIC COMMENT

To: The Parties of Record and Interested Persons in Case No. 9449

On May 31, 2017, the Public Service Commission (“Commission”) issued Order No. 88233 in the above-captioned proceeding in which, among other things, it directed AltaGas Ltd., and WGL Holdings, Inc. (“Applicants”) to work with the Commission’s Executive Secretary to schedule the dates and locations for two evening public hearings to be conducted in this matter. The Commission also determined that the two public comment hearings will be held prior to the evidentiary hearings.

The Washington Gas Light Company (“WGL”) is hereby directed to publish, once in each of the two (2) successive weeks prior to each hearing date, notice of the public hearing and the opportunity for public comment by a display advertisement in newspapers of general circulation in each county within the WGL service territory. In the display advertisement, WGL is directed to publish the case caption and case number in addition to the date, time, place and purpose of the hearing. Proof of publication shall be filed with the Commission on or before the date of the hearings. Additionally, WGL and the Applicants shall place on their respective home pages a notice of the hearings, including the purpose of the hearings, in a manner that a customer need not click on a link to determine the date, time, location and purpose of the hearings.

Furthermore, WGL is directed to issue either a bill message or bill insert to its Maryland customers in their respective billing cycle that runs closest and prior to the hearing dates, announcing the date, time, place, and purpose of the hearing. Finally, the Applicants and WGL are directed to utilize social media or other means of communication at its disposal to further notify its customers of the public hearings, as appropriate.
