

NOTICE OF REVISED PROCEDURAL SCHEDULE AND NOTICE OF PUBLIC COMMENT HEARINGS

To: Service List for Case No. 9472 and Interested Persons

On April 12, 2018, the Potomac Electric Power Company ("Pepco" or "Company") on behalf of the Parties¹ in the above-captioned proceeding notified the Maryland Public Service Commission ("Commission") that they had reached a settlement in principle and requested a suspension of the procedural schedule.² On April 12, 2018, the Commission issued a Notice suspending the procedural schedule, including the evidentiary hearings scheduled for June 4 through 13, 2018. Pepco indicated that the Parties intended to file their agreement in writing promptly. The Parties also requested that the Commission set an evidentiary hearing on the settlement prior to May 15, 2018.

On April 20, 2018, Pepco, on behalf of the Settling Parties,³ filed a Joint Motion for Approval of Agreement of Stipulation and Settlement ("Settlement Agreement"). Specifically, the Settling Parties request that the Commission: 1) approve the Stipulation and Settlement set forth in this document ("Stipulation") in full settlement of this proceeding; 2) waive such provisions of the Commission's Rules and Regulations as may be necessary to permit relief requested herein; and 3) approved attached tariffs (Exhibit 1) with an effective date of June 1, 2018.

Settlement Evidentiary Hearing:

• Wednesday, May 16, 2018, beginning at 1:00 p.m.

The evidentiary hearing will be held in the Commission's 16th Floor Hearing Room at 6 St. Paul Street, Baltimore, Maryland 21202. The Commission reserves the right to modify the start time of the hearing, as necessary.

Evening hearings for the purpose of receiving public comment on the Settlement Agreement associated with Potomac Electric Power Company's application for adjustments to its Maryland retail rates for the distribution of electric energy are hereby scheduled as follows:

Written Public Comments:

• Written public comments on the settlement agreement may also be filed by Thursday, May 24, 2018. Original signed paper comments shall be submitted via U.S. Mail to David J. Collins, Executive Secretary, Maryland Public Service Commission, William Donald Schaefer Tower, 6 St. Paul Street, 16th Floor, Baltimore, Maryland 21202, and reference "Case No. 9472 – Public Comment."

Pepco is hereby directed to publish, once in each of the two (2) successive weeks prior to each public comment hearing date, notice of the public hearing and the opportunity for public comment by a display advertisement in newspapers of general circulation in each county within the Pepco service territory. In the display advertisement, Pepco is directed to publish the case caption and case number in addition to the date, time, place and purpose of the hearing. Proof of publication shall be filed with the Commission on or before the date of the hearings. Additionally, Pepco shall place on its home page a notice of the hearings, including the purpose of the hearings, in a manner that a customer need not click on a link to determine the date, time, location and purpose of the hearings.

Furthermore, Pepco is directed to issue a bill message, bill insert, or other written mailed notification to its Maryland customers in their respective billing cycle that runs closest and prior to the hearing dates, announcing the date, time, place, and purpose of the hearing. Finally, Pepco is directed to utilize social media or other means of communication at its disposal to further notify its customers of the public hearings, as appropriate.
