## **NOTICE OF INITIATING A PROCEEDING AND REQUEST FOR COMMENTS**

On January 19, 2018, the Public Conference 44 Electric Vehicle Work Group Leader filed a Petition for Implementation of a Statewide Electric Vehicle Portfolio ("Petition").<sup>1</sup> Specifically, the Work Group Leader recommends the Maryland Public Service Commission ("Commission") docket a proceeding to consider the Work Group's proposal to implement a Statewide electric vehicle portfolio designed to: address barriers to deployment of electric vehicles; increase the efficiency and reliability of the electric distribution system; and lower electricity use at times of high demand. The Petition also included a proposed procedural schedule to yield a Commission decision in this matter by May 18, 2018. Furthermore, the Work Group Leader acknowledged that the proposal does not constitute a consensus document from all members of the Work Group.

On January 29, 2018, the Office of People's Counsel ("OPC") filed a letter also indicating that the Work Group Proposal was not a consensus document and suggested an alternate path forward for the Commission to consider potential Utility-run electric vehicle programs in Maryland.<sup>2</sup> OPC supports the request for the Commission to docket a proceeding, but believes that a full evidentiary process, with associated discovery privileges, is necessary to thoroughly investigate and consider the approximate \$100 million expenditure associated with the proposal. OPC therefore recommends that the Commission hold a prehearing conference to establish a formal procedural schedule that, among other things, sets a date by which the Utilities must file complete electric vehicle program proposals including a supporting cost-benefit analysis and full revenue requirement breakdown and recovery mechanism for each rate class.
