NOTICE OF HEARING FOR PUBLIC COMMENT

On September 5, 2019, the Maryland Public Service Commission ("Commission") issued an Order to Show Cause, 1 requiring Washington Gas Light Company ("WGL") to file a response to the probable cause findings of the National Transportation Safety Board in its June 10, 2019 "Pipeline Accident Report," WGL's plan for implementing the recommendations in NTSB's report, and an evaluation of the risks associated with the plan as well as all measures WGL intends to take to minimize these risks.² The Commission stated that following WGL's compliance filings and the replies of other parties, it would schedule a hearing in the Silver Spring area to receive input on the issues raised in the Order to Show Cause and allow members of the public, public officials, WGL, and any other interested party the opportunity to provide comment for the Commission's consideration. On October 18, 2019, WGL filed its Response to Order to Show Cause ("Response"), and on November 18, 2019, the Commission received replies from the
