## REVISED SCHEDULING NOTICE AND EXTENSION OF PUBLIC COMMENT DEADLINE

On August 28, 2020, the Commission postponed the evidentiary hearings in this case. The Commission hereby reschedules the evidentiary hearings for September 24 and 25, 2020.
