NOTICE INITIATING A NEW DOCKET, NOTICE OF VIRTUAL HEARING, AND REQUEST FOR COMMENTS

On December 1, 2021 the Leader of the Electric Vehicle Work Group in Public Conference 44 filed a letter asking the Commission to docket a new proceeding to examine a Benefit Cost Analysis (BCA) framework for all Distributed Energy Resources (DERs) in Maryland. In support of this request, the filing suggests that a framework that measures cost-effectiveness and potential rate impacts across all DERs will ensure adequate review of projects and consistency in the valuation of relevant value streams, and could potentially assist the Commission in evaluating utility investment strategies and distribution system planning practices. Finally, the filing suggests using the Commission's existing work on BCA, including in the Electric Vehicle and EmPOWER workgroups, as well as the National Standard Practice Manual, to inform the development of a unified DER BCA.

The Commission hereby initiates Case No. 9674 to explore the process for developing a proposed unified BCA framework for DERs in Maryland. In scoping and launching this initiative, the Commission will accept comments from interested parties on the limited topics of: (1) the practical use of a unified BCA for stakeholders, (2) the role of a unified BCA in Commission proceedings; and (3) suggested methodologies, procedures, or vehicles for developing the unified BCA. Interested stakeholders shall submit comments by February 16, 2022.²

The Commission will hold a virtual, legislative-style hearing to consider the comments at 1 p.m. on February 23, 2022.
