NOTICE OF EVENING HEARINGS FOR PUBLIC COMMENT

On June 22, 2018, and July 25, 2018, the Maryland Public Service Commission (“Commission”) issued Order No. 88758 and Order No. 88781, respectively, in the above-captioned proceedings in which, among other things, it directed Washington Gas Light Company (“WGL”) to contact the Executive Secretary to establish the dates and locations for the evening public hearings to be conducted in these proceedings. The Commission has concluded that in the interest of public convenience, and for a more efficient and a better use of the parties’ resources, the public hearings in these separate proceedings shall be combined on the same dates in the two locations at which the hearings will be conducted.

WGL is hereby directed to publish, at least twice prior to each of the hearing dates, notice of the public hearing and the opportunity for public comment by a display advertisement in newspapers of general circulation in each county or municipality within the WGL service territory. In the display advertisement, WGL is directed to publish each case caption and applicable case number in addition to the date, time, place, and purpose of the hearing. Proof of publication shall be filed with the Commission on or before the dates of hearing. Additionally, WGL shall place on its home page a notice of the hearings, including the purpose of the hearings, in a manner that a customer need not click on a link to determine the date, time, location, and purpose of the hearings. Finally, WGL is directed to utilize email, its routinely used social media platforms, or other means of communication at its disposal to further notify its customers of the hearings, as appropriate.
