Public Hearings Scheduled in Wicomico, Worcester Counties for New Delmarva Power Transmission Line

(BALTIMORE, MD-June 15, 2016) – Two public hearings will be held on Delmarva Power’s proposal to construct a new 138 kilovolt overhead transmission line through Wicomico and Worcester counties to the Maryland/Virginia state line.

Members of the public who wish to comment on the matter are welcome to attend the proceedings before Chief Public Utility Law Judge Terry Romine. The proposed project would be constructed on existing right-of-way from the Piney Grove substation near Salisbury to the Wattsville substation in Wattsville, Virginia, and includes an upgrade to the existing transmission line crossing of the Pocomoke River near Snow Hill.
