NOTICE OF HEARING

The Commission hereby gives notice that it will conduct a legislative-style hearing on Tuesday, May 2, 2023, beginning at 10:00 a.m. in the Frank O. Heinz Hearing Room, William Donald Schaefer Tower, 16th Floor, 6 St. Paul Street, Baltimore, Maryland, to consider the Q3/Q4 2022 EmPOWER Maryland semi-annual reports¹ of The Potomac Edison Company,² Baltimore Gas and Electric Company,³ Delmarva Power & Light Company,⁴ Potomac Electric Power Company,⁵ Southern Maryland Electric Cooperative, Inc.,⁶ and Washington Gas Light Company⁷ (collectively, the “Joint Utilities”), and the Maryland Department of Housing and Community Development (“DHCD”).⁸
