On February 9, 2016, the Maryland Public Service Commission (“Commission”) provided notice that it will conduct hearings on May 3 and 5, 2016 beginning at 10:00 a.m. and May 4, 2016 beginning at 1:00 p.m. in the Commission’s 16<sup>th</sup> Floor Hearing Room, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202 to consider the EmPOWER Maryland Semi-Annual Reports for the period from July 1, 2015 through December 31, 2015 (“Reports”) filed by Baltimore Gas and Electric Company (Case No. 9154), The Potomac Edison Company d/b/a Allegheny Power (Case No. 9153), Southern Maryland Electric Cooperative, Inc. (Case No. 9157), Potomac Electric Power Company (Case No. 9155), Delmarva Power & Light Company (Case No. 9156), Washington Gas Light Company (Case No. 9362), and the Department of Housing and Community Development with respect to its Limited Income Energy Efficiency and Multifamily Energy Efficiency and Housing Affordability Programs (“Reports”).<sup>1</sup>
