**Notice of Rulemaking (RM81), Rulemaking Session, and Request for Comments**

**On September 28, 2023, the Leader of the PC44 Interconnection Work Group (“Work Group”) submitted a Phase V Final Report and Petition for Rulemaking — Revisions to Subtitle 50 of Title 20, Code of Maryland Regulations.<sup>1</sup> Accordingly, the Commission hereby initiates an Administrative Docket, RM81, to consider revisions to Code of Maryland Regulations (“COMAR”) 20.50.09 – relating to small generator facility interconnections.**

Comments on the Report as well as the Rulemaking Petition and the accompanying regulations shall be e-filed by November 9, 2023.<sup>2</sup> The comments should be addressed to Andrew S. Johnston, Executive Secretary, Maryland Public Service Commission, William Donald Schaefer Tower, 6 St. Paul Street, 16th Floor, Baltimore, Maryland 21202. The Administrative Docket number (RM81) must appear in the subject line of the cover letter.<sup>3</sup>

The Commission also gives notice that it will conduct a rulemaking session on December 5, 2023, beginning at 10:00 a.m. in the Frank O. Heintz Hearing Room, on the 16th Floor of the William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland.

**The purpose of the rulemaking session is to consider whether to publish for notice and comment, the proposed revisions to COMAR 20.50 as submitted in the September 28, 2023, Work Group report, or as revised based on comments received. If the Commission approves the proposed regulations for publication, the proposed regulations will be published in the Maryland Register for notice and comment as provided for by the Maryland Administrative Procedures Act.**
