Maryland Public Service Commission Schedules Public Hearing for LeGore Bridge Solar Project in Frederick County

(BALTIMORE, MD-March 16, 2017) – A public comment hearing will be held on **Thursday, March 30, 2017** on the application of LeGore Bridge Solar Center, LLC to construct a 20.0 MW solar generating facility in Frederick County. The hearing will begin at **7pm** in the meeting room of the **Hampton Inn, 1565 Opposumtown Pike in Frederick**. An evidentiary hearing is scheduled for the same location at 6:30 pm. Members of the public who wish to comment on the matter are welcome to attend the public hearing before Public Utility Law Judge Robert H. McGowan.

According to the application, the solar facility will be constructed on a 170-acre portion of property south of LeGore Road and along the northern and southern sides of Clyde Young Road in Keymar, Maryland.
