Public Hearing Scheduled in Worcester County for Longview Solar Project

(BALTIMORE, MD-March 17, 2016) – A public hearing for comment will be held on **Thursday, March 31, 2016 at 7pm** in the matter of the application of Longview Solar, LLC to construct a 20 MW solar photovoltaic generating facility (LS-Heron Solar Farm) in Worcester County, to be located at 8925 Libertytown Road in Berlin. The application has been docketed by the Maryland Public Service Commission as Case No. [9403](#).
