Public Hearing Scheduled in Worcester County for Longview Solar Project

(BALTIMORE, MD-March 24, 2016) – A public hearing for comment will be held on **Thursday, April 7, 2016 at 7pm** in the matter of the application of Longview Solar, LLC to construct a 15 MW solar photovoltaic generating facility (LS-Seabeach Solar Farm) in Worcester County, to be located on Public Landing Road in Snow Hill. The application has been docketed by the Maryland Public Service Commission as Case No. [9405](#).
