Maryland PSC sets Public Hearing on BGE Transmission Line Project in Harford County

(BALTIMORE, MD-January 27, 2021) – The Maryland Public Service Commission has scheduled a virtual public comment hearing on the application by Baltimore Gas and Electric Company to replace a 1.3-mile portion of an existing 115kV transmission line that runs from Edgewood to Perryman across the Bush River in Harford County, Maryland.

According to BGE, the project is needed to improve reliability and critical infrastructure. The applicant proposes to replace three steel lattice towers and four wood H-frames with nine steel monopoles, which will be approximately 125-145 feet higher than the lattice towers, resulting in higher spans and clearances that meet current standards, improve safety, and minimize sailboat contact with the wires.

The hearing will be held on **Tuesday, February 9, 2021 at 7:00 p.m.** before Chief Public Utility Law Judge Ryan C. McLean. Members of the public who wish to speak at the virtual hearing should send an email to psc.pulj@gmail.com by 12 noon on Monday, February 8, 2021. The hearing will be held on the WebEx platform and participants will receive an email with the link to join the hearing.
