Maryland PSC to Hold Virtual Public Comment Hearing for Fairview Farm Solar Project in Harford County

(BALTIMORE, MD-December 1, 2020) – The Maryland Public Service Commission will hold a virtual public comment hearing on the request by PTR HoldCo, LLC to build the 30 MW Fairview Farm solar facility in Harford County, Maryland. The hearing will be held **Tuesday, December 15, 2020 at 7 p.m. via WebEx** and will be conducted by Public Utility Law Judge Christine Burke. The hearing will include a presentation by the applicant.

PTR HoldCo proposes to construct the project on approximately 140 acres of property owned by Fairview Farms, LLC, located at 2000 Calvary Road in Bel Air. The project will include approximately 102,000 photovoltaic panels, 13 power centers, and two interconnection points along Calvary Road.
