NOTICE OF HEARING

To: All Parties of Record and Interested Persons

The Public Service Commission ("Commission") hereby gives notice of a hearing on Thursday, June 11, 2015, at 3:00 p.m., for the Standard Offer Service ("SOS") Bid Monitor consultant and the Commission's Technical Staff to brief the Commission on the conduct of the June 8, 2015 solicitations for offers for contracts for a portion of the residential loads by The Potomac Edison Company ("PE") and the results, in conjunction with the hearing for review of the PE's, Baltimore Gas and Electric Company's, Delmarva Power & Light Company's and Potomac Electric Power Company's Type II SOS procurement results.¹ PE is hereby directed to provide Commission Staff no later than 9 a.m., Wednesday, June 10, 2015, with individual class retail bill impact data consistent with the results of the June 8, 2015 bids to ensure that Staff is able to file its written testimony in the matter prior to the hearing commencement time.

The hearing will be held in the Commission's 16th Floor Hearing Room, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202. As discussed in Order No. 81102 in Case No. 9064,² the Commission will conduct a review of confidential and highly

commercially sensitive bidder specific data during the process and at the hearings. Additionally, the Commission will solicit remarks from any of the parties and members of the public following the briefing. To the extent necessitated by confidentiality considerations, the Commission will employ *in camera* procedures.
