## **NOTICE OF HEARING**

The Commission hereby gives notice of a hearing on Thursday, January 16, 2025, at 2:00 p.m., for the Standard Offer Service ("SOS") Bid Monitor consultant and the Commission's Technical Staff to brief the Commission on the conduct of the January 13, 2025 solicitations for offers for a portion of the residential customer loads by The Potomac Edison Company ("PE") and the results, in conjunction with the hearing for review of PE's, Baltimore Gas and Electric Company's, Delmarva Power and Light Company's and Potomac Electric Power Company's Type II SOS procurement results. The IOUs are hereby directed to provide Commission Staff no later than 12:00 Noon, Wednesday, January 15, 2025, with individual class retail bill impact data consistent with the results of the January 13, 2025 bids to ensure that Staff is able to file its written testimony in the matter prior to the hearing commencement time.

The public briefing, therefore, will include only the information that can be made public under the provisions of the request for proposals and the full requirements service agreement.
