## **Notice of Request for Comments Related to MEAP Funding Exhaustion**

On April 22, 2024, the Commission was alerted by the Maryland Department of Human Services' (DHS) Office of Home Energy Programs (OHEP) that there was an exhaustion of funds for the Maryland Energy Assistance Program (MEAP)<sup>1</sup> and the Gas Arrearage Retirement Assistance Program (GARA)<sup>2</sup>, and that as a result, OHEP would have to deny all customer applications to MEAP and GARA starting on April 17, 2024 and extending until June 30, 2024 (before the start of Fiscal Year 2025). As a result of the exhaustion of funds, customers who might have otherwise been eligible for MEAP and GARA grants will now have their applications automatically denied. This circumstance may exacerbate customer arrearages and lead to a higher rate of service terminations. The Commission has communicated with DHS directly and has received data outlining the customer impacts resulting from the exhaustion of MEAP funding on May 23, 2024.<sup>3</sup>

Based on information provided by OHEP, the utility companies are aware of the current shortfall in MEAP and GARA funding. The Commission understands the timeliness of this matter and therefore directs that all Maryland electric and gas utilities file brief comments by Tuesday

June 4, 2024 discussing what actions (if any) have been or may be taken by the utility in order to

protect customers due to the anticipated denial of all MEAP and GARA applications for the time

period from April 22, 2024 – June 30, 2024, as well as discussing any additional information

related to this matter. The comments should also address whether a limited moratorium on service

terminations, or any other action, should be imposed during the remainder of fiscal year 2024 or

beyond to remedy the situation created by the exhaustion of funds. Other interested persons may

also file comments either addressing the issues identified by the Commission in this Notice or in

response to the comments filed by the utilities.

Written comments must be received by June 4, 2024. All filings should be addressed to
