The Public Service Commission of Maryland ("Commission") issued Order No. 87991 on January 20, 2017 in the above-captioned proceeding for the purpose of, among other things, establishing the disbursement schedule of monies from the customer investment fund ("CIF") for the second half of fiscal year ("FY") 2017 and for FY 2018. Due to the limited funding available for disbursements during the remainder of FY 2017, however, it is necessary to shift certain scheduled disbursements into FY 2018; although, the total amount of authorized funding for each CIF Recipient and CIF Program remains unaltered from Order No. 87991. Therefore, the disbursement schedules for FY 2017 and FY 2018 are modified accordingly, as appended to this Order.¹
