## ORDER INITIATING DOCKET, SUSPENDING TARIFF REVISIONS, AND SCHEDULING PREHEARING CONFERENCE

On October 26, 2020, Potomac Electric Power Company ("Pepco") submitted to the Commission an application for authority to adjust its retail rates for the distribution of electric energy and implement a Multi-Year Plan ("MYP") in its Maryland service territory pursuant to *Annotated Code of Maryland*, Public Utilities Article ("PUA") §§ 4-203, 4-204 and 7-505(c)(1) ("Application"). In support of its Application Pepco also filed supporting testimony, data required by the Commission's general filing requirements, and proposed rate schedules with an effective date of November 25, 2020. Pepco has also implemented an electronic discovery data base that will allow all parties to access discovery responses electronically.

Pepco proposes a three-year MYP covering the three-year period April 1, 2021 through March 31, 2024. The costs in the proposed MYP cover investments made since Pepco's last base rate case<sup>1</sup> and forecasted to be made through March 31, 2024. Pepco

projects spending approximately \$259 million in 2020 and \$1.09 billion over the four-year calendar period 2021-2024 on upgrades and improvements to Pepco's Maryland distribution system, and requests authority to address claimed (*i.e.*, projected) electric revenue deficiencies of \$44 million for the 12 months ending March 31, 2022, \$78 million for the 12 months ending March 31, 2024.

Pepco's proposal includes the acceleration of certain tax benefits and a pause in amortization expense that results in no overall distribution rate increase for customers during the first two years of the MYP, and a partial offset to overall distribution rates in the third year of the MYP. Accordingly, in April of 2023, customers would see an overall distribution rate increase, after off-sets, of \$56 million. The impact of the requested April 2023 rate increase on the typical residential Standard Offer Service customer using 811 kWh per month is \$5.50 per month, representing a 4.4% increase.

Pepco also proposes including five "tracking only" Performance Incentive Mechanisms ("PIMs") as part of its proposed MYP, covering reliability measures (Customer Average Interruption Duration Index and Customers Experiencing Multiple Interruptions 4), customer service measures (First Call Resolution), and environmental related measures (Electric Vehicle charger installation and Green House Gas reductions).<sup>2</sup> Additionally, in accordance with Order No. 89542 in Case No. 9639,<sup>3</sup> Pepco has established a regulatory asset to record any incremental impacts related to the

COVID-19 pandemic, and Pepco is seeking recovery of the regulatory asset over the term of the MYP.<sup>4</sup>

A virtual prehearing conference in this matter is hereby set for Monday, November 23, 2020, beginning at 10:00 a.m. The purpose of the hearing is to set a procedural schedule for this proceeding, consider any petitions to intervene that have been filed, and consider any other preliminary matters requested by the parties. Petitions to intervene shall be filed by Thursday, November 19, 2020. Furthermore, discovery commences immediately for Pepco, the Commission's Technical Staff, and the Maryland Office of People's Counsel.

**ORDERED:** (1) That proceedings to consider the Application and the justness and reasonableness of Potomac Electric Power Company's Multi-Year Plan, proposed rates, terms, and conditions of its tariff revisions are hereby instituted by the Commission:

- (2) That, pursuant to PUA § 4-204, the tariff revisions filed by Potomac Electric Power Company's are suspended for an initial period of 150 days from November 25, 2020;
- (3) That discovery commences immediately for Potomac Electric Power Company, the Commission's Technical Staff, and the Maryland Office of People's Counsel;
- (4) That interested parties shall file petitions to intervene by November 19, 2020;
- display advertisement to be published in a newspaper(s) in general circulation throughout its service area at least two times prior to November 16, 2020, that includes a description of the matter on which the prehearing conference is being held and the time, date, method, and purpose of the prehearing conference scheduled for November 23, 2020. The notice shall also advise persons who seek to intervene in this proceeding that any petition to intervene, shall be filed<sup>7</sup> with Andrew S. Johnston, Executive Secretary, Maryland Public Service Commission, William Donald Schaefer Tower, 6 St. Paul Street, 16th Floor, Baltimore, Maryland 21202, by November 19, 2020;
- (6) That Potomac Electric Power Company shall file a proof of publication on or before the date of the prehearing conference;
- (7) That Potomac Electric Power Company also shall place on its home page a notice of the prehearing conference and the date by which petitions to intervene in the

conference, as appropriate.
