## NOTICE OF VIRTUAL PUBLIC COMMENT HEARINGS

On October 26, 2020, Potomac Electric Power Company ("Pepco") submitted to the Commission an application for authority to adjust its retail rates for the distribution of electric energy and implement a Multi-Year Plan ("MYP") in its Maryland service territory pursuant to *Annotated Code of Maryland*, Public Utilities Article ("PUA") §§ 4-203, 4-204 and 7-505(c)(1) ("Application"). A prehearing scheduling conference was held on November 23, 2020, during which the Commission adopted a procedural

three-year period April 1, 2021 through March 31, 2024. The costs in the proposed MYP cover investments made since Pepco's last base rate case and forecasted to be made through March 31, 2024. Pepco projects spending approximately \$259 million in 2020 and \$1.09 billion over the four- year calendar period 2021-2024 on upgrades and improvements to Pepco's Maryland distribution system, and requests authority to address claimed (*i.e.*, projected) electric revenue deficiencies of \$44 million for the 12 months ending March 31, 2022, \$78 million for the 12 months ending March 31, 2023 and \$110 million for the 12 months ending March 31, 2024. Pepco's proposal includes the acceleration of certain tax benefits and a pause in amortization expense that would result in no overall distribution rate increase for customers during the first two years of the MYP, and a partial offset to overall distribution rates in the third year of the MYP. Accordingly, in April of 2023, customers would see an overall distribution rate increase, after off-sets, of \$56 million. The impact of the requested April 2023 rate increase on the typical residential Standard Offer Service customer using 811 kWh per month would be \$5.50 per month, representing a 4.4% increase.

schedule for the matter, except for the schedule for evening public hearings.<sup>2</sup>

platforms, such as Twitter or Facebook, and any other means of communication at its

disposal to further notify its customers of the public hearings and the dates by which

public comments must be filed.
