Pursuant to Public Utilities Article, *Annotated Code of Maryland*, §7-211(h)(2), House Bill 169, and Order No. 90546, The Potomac Edison Company, Baltimore Gas and Electric Company, Delmarva Power & Light Company, Potomac Electric Power Company, Southern Maryland Electric Cooperative, Inc., and Washington Gas Light Company (collectively, the EmPOWER Utilities) and the Maryland Department of Housing and Community Development (DHCD) will file their energy efficiency, conservation, and demand response plans for the 2024-2026 program cycle by August 1, 2023, for the Commission's review. On October 31, 2023, the Commission will conduct a hearing on the fifth semi-annual reports for the 2021-2023 program cycle, and the Commission is currently planning to conduct a hearing on the 2024-2026 plans from October 31 through November 3. Accordingly, the Commission concludes that it will be more efficient and effective to open a new proceeding for the 2024-2026 EmPOWER Maryland programs, and a new docket, Case No. 9705, is hereby initiated for the review of the 2024-2026 plans.
