PROCEDURAL ORDER

On June 9, 2023, the Commission's Technical Staff ("Staff"), Maryland Office of People's Counsel ("OPC"), Baltimore Gas and Electric Company ("BGE"), and the Maryland League of Conservation Voters and Sierra Club notified the Commission that the parties agreed to the following procedural schedule for Case No. 9696:

- (a) Direct Testimony for Staff, OPC, and other intervenors shall be filed by July 25, 2023;
- (b) Rebuttal Testimony for BGE and Cross-Rebuttal for intervenors shall be filed by August 25, 2023;
- (c) Public comments shall be filed by September 15, 2023;
- (d) Reply/Surrebuttal Testimony for intervenors shall be filed by September 26, 2023;
- (e) Evidentiary hearings shall be conducted on October 2, 2023, and October 3, 2023; and
- (f) Initial Briefs shall be filed by November 2, 2023.

Discovery continues for all parties. All testimony and discovery shall be served electronically to each of the parties to avoid delay in receipt, unless the parties agree to a different format. Parties shall ensure that the correct email of the person(s) to whom the testimony and discovery should be sent are updated on the service list for this matter.

IT IS, THEREFORE, this 16th day of June in the year Two Thousand Twenty-Three, by the Public Service Commission of Maryland, **ORDERED** that Parties shall file pleadings in this proceeding as follows:

- (1) Parties, excluding BGE, shall file direct testimony by July 25, 2023;
- (2) Parties shall file rebuttal testimony by August 25, 2023;
- (3) Public comments shall be filed by September 15, 2023;
- (4) Intervening parties shall file surrebuttal testimony by September 26, 2023;
- (5) Evidentiary hearings shall be conducted on October 2, 2023, and October 3 2023; and
- (5) Parties shall file a brief by November 2, 2023.

The Petitions to Intervene of the Maryland League of Conservation Voters and Sierra Club and the Maryland Energy Administration are hereby granted. Pleadings shall be submitted to Andrew S. Johnston, Executive Secretary, Maryland Public Service Commission, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202. The Commission reserves the right to revise the hearing schedule, as needed.
