Notice of Virtual Legislative-Style Time-of-Use Hearing

On October 4, 2021 Baltimore Gas and Electric Company ("BGE"), Potomac Electric Power Company ("Pepco") and Delmarva Power & Light Company ("Delmarva Power") (collectively "the Joint Utilities") submitted the PC44 Time-of-Use ("TOU") Pilot Final Pilot Evaluation. The filing included 1) the Brattle Group's evaluation of the two-year pilot period; 2) assessments by each utility; 3) evaluation metrics for each utility; 4) an overview of Oracle's Behavioral Load Shaping ("BLS") communications tool; and 5) results of pilot participant surveys. The Joint Utilities also made several recommendations regarding ways to modify the pilot offering in advance of proposing this TOU as a full rate offering.

The Commission hereby requests that Workgroup Recommendations regarding the future of the TOU rate offering be filed on January 6, 2022. The Report should address the Joint Utilities' areas of concern as well as any concerns raised by other stakeholders. Where possible, the Report should provide consensus recommendations and highlight any areas of disagreement for Commission resolution. The Commission also hereby requests that written comments be
