NOTICE OF RETAIL GAS MARKET CONFERENCE

To: All Jurisdictional Gas Companies, Licensed Gas Suppliers and Applicants, and Other **Interested Persons**

On November 28, 2017, the Public Service Commission ("Commission") will hold a Public Conference to review preparations for the upcoming winter natural gas supply. The Commission has determined that a public discussion of the preparations to meet the gas market demand, as well as expectations of market conditions for the 2017-2018 winter, will be beneficial. This discussion is intended to inform the Commission about preparations that have been made and to increase awareness among customers about upcoming market conditions and the potential impact on service costs and reliability. All companies in their comments should detail the costs of summer hedges for storage injection, other summer storage injection costs, and the cost of any 2016-2017 winter hedges for gas delivery. Additionally, participants should discuss the potential costs and benefits from hedging for summer 2018 injections and other future periods given the current level of natural gas prices. To the extent competitive conditions allow, the Commission further welcomes information from suppliers.
