Maryland PSC to Hold Public Comment Hearing for Kumquat & Citron Solar Project

(BALTIMORE, MD-March 24, 2021) – The Maryland Public Service Commission will hold a virtual public comment hearing on the plan by Kumquat & Citron Cleantech, LLC to build a 7.2 MW solar generating facility in Wicomico County, Maryland. The hearing, to be conducted by Public Utility Law Judge Jennifer Grace, will be held on **Tuesday**, **April 6, 2021 at 7:00 p.m.**

The project is slated to be constructed on approximately 25 acres owned by Flonium Power, LLC, located at 29593 Foskey Lane, near the intersection with Connelly Mill Road, in Delmar, Maryland and will include solar generation, interconnection, and storage.
