Maryland PSC Seeks Public Input on Pepco Rate Increase Request

(BALTIMORE, MD-April 24, 2019) – The Maryland Public Service Commission will hold two public comment hearings next month on the request by the Potomac Electric Power Company (Pepco) to increase its electric distribution rates by nearly \$29.3 million. Pepco serves 578,000 customers in Montgomery and Prince George's counties. The proposed rates would result in an increase of about \$3.51 on the monthly bill of the average residential customer.

Members of the public who wish to comment on the matter are welcome to attend one or both of the hearings before Chief Public Utility Law Judge Ryan C. McLean. The hearings are scheduled as follows:
