## **Pepco Rate Case Hearings Scheduled**

(BALTIMORE, MD-August 23, 2016) – The Maryland Public Service Commission will hold two public hearings on a request by Potomac Electric Power Company (Pepco) to increase its electric distribution rates by \$104 million (an increase of about \$13 a month for the typical residential customer). Pepco provides electricity to about 560,000 customers in Prince George's and Montgomery counties in Maryland.
