Public Hearing Scheduled for Dan's Mountain Solar Project

(BALTIMORE, MD-March 8, 2016) – A public hearing for comment will be held on **Tuesday, March 22, 2016 at 7pm** in the matter of the application of Dan's Mountain Solar, LLC to construct an 18.36 MW solar photovoltaic generating facility in Allegany County. The application has been docketed by the Maryland Public Service Commission as Case No. [9400](#).
