### **Public Hearing Scheduled for Sandpiper Energy Rate Increase Request**

(BALTIMORE, MD—March 4, 2016)--A public hearing for comment will be held on **Friday, March 18, 2016 at 6:30pm** in the matter of Sandpiper Energy Inc.'s application to increase its natural gas and propane rates by \$948,000. The application has been docketed by the Maryland Public Service Commission as Case No. [9410](#). Sandpiper serves nearly 11,000 residential, commercial and industrial natural gas and propane customers in Worcester County, Maryland.
