Public Hearing Set for Pepco's Transmission Line Upgrade in Prince George's County

(BALTIMORE, MD) – Local residents and other interested members of the public are invited to comment on a plan by Potomac Electric Power Company to rebuild an existing 10.2 mile 230 kV tower line in Prince George's County. The hearing will take place on **Tuesday, January 30, 2024** at **6:30 p.m.** at Dr. Henry Wise Jr. High School, 12650 Brooke Lane in Upper Marlboro before Public Utility Law Judge Kristin Case Lawrence.

Pepco has applied to the Maryland Public Service Commission for what is known as a Certificate of Public Convenience and Necessity (CPCN), which grants an applicant the authority to construct an energy generating station or high-voltage transmission line in Maryland. According to the application, the project would originate at Pepco's Oak Grove substation and run to the company's Talbert substation, all within Pepco's existing right-of-way. Pepco notes the project is necessary to prevent failure of the structures supporting the transmission line, as well as to maintain compliance with reliability standards and avoid potential outages.

The hearing will include a presentation by Pepco, the Power Plant Research Program of the Maryland Department of Natural Resources, the Maryland Office of People's Counsel, and the Commission's Technical Staff, followed by an opportunity for members of the public to comment on the proposed project.
