**Modifications to Perryman Generating Station  
Set for Public Hearing**  
*Public invited to weigh in at virtual hearing*

(BALTIMORE, MD) – Local residents and other interested members of the public are invited to share their comments on proposed modifications to the Perryman Generating Station in Harford County. A virtual public comment hearing will take place on **Tuesday, July 12, 2022 at 7 p.m.** Public Utility Law Judge Christine L. Burke will preside.

Constellation Power Source Generation, LLC has applied to the Maryland Public Service Commission to modify its Certificate of Public Convenience and Necessity (CPCN) for the Perryman Generating Station, which includes six simple-cycle combustion turbines used to generate power during periods of peak demand. According to its application, CPSG seeks to modify three of the existing oil-fueled combustion turbine units to enable them to self-start without relying on electrical power from the grid and to support a restart of the regional electrical system in the event of a grid outage. The modification primarily consists of the addition of two 2,750 kilowatt (kW) diesel engine generator sets. CPSG will make a presentation about the project at the hearing.

The hearing will be held on the Webex platform and participants will receive an email with the link to join in.
