Maryland PSC Schedules First Public Hearing for Energy Ventures Solar Project in Prince George's County

(BALTIMORE, MD-May 23, 2018) – The Maryland Public Service Commission will hold the first of two public comment hearings on the application of Energy Ventures IPP, LLC to construct a 10 MW solar generating facility in Prince George's County, Maryland. The hearing will be held on **Wednesday, June 6, 2018, at 7:00 p.m. at the Brandywine Volunteer Fire Department, 14201 Brandywine Road in Brandywine, Maryland.** Members of the public who wish to comment on the matter are welcome to attend the hearing before Public Utility Law Judge Jennifer J. Grace. A second public comment hearing will be held on July 24, 2018 at a time and location to be determined.

According to the application, the solar facility, Mattawoman Solar Project, will be constructed at the Soil Safe, Inc.-Brandywine Facility, which is located north of the terminus of Mattawoman Drive and south of Timothy Road in Brandywine. The application is available for public inspection and copying at the Maryland-National Capital Park and Planning Commission, County Administration Building, 14741 Governor Oden Bowie Drive in Upper Marlboro.
