Maryland Public Service Commission Schedules Public Hearing for Jones Farm Lane Solar Project in Queen Anne's County

(BALTIMORE, MD-July 25, 2017) – The Maryland Public Service Commission will hold a public comment hearing on the application of Jones Farm Lane Solar, LLC to construct a 56.7 MW solar generating facility in Queen Anne's County. The hearing will be held on **Tuesday, August 8, 2017** at **6:30pm** at the **Holiday Inn, 1020 Kent Narrows Road in Grasonville.** Members of the public who wish to comment on the matter are welcome to attend the hearing before Public Utility Law Judge Robert H. McGowan.

According to the application, the solar facility will be constructed on approximately 337 acres of property located at 48 Jones Farm Lane in an unincorporated area of Queen Anne's County.
